#### I. COMPANY PROFILE

KIOCL Limited was incorporated under the Indian Companies Act, 1956 with the objective to mine low grade Magnetite Iron Ore & beneficiate the same for further use. The Company has set up Iron Ore Concentrate Plant at Kudremukh and Pellet Plant and Blast Furnance at Mangalore. KIOCL is a schedule - 'A' Mini Ratna CPSE in the Mineral and Metals sector under the administrative control of Ministry of Steel.

The authorized and paid up capital of the Company was Rs. 675 crores and Rs. 634.51 crores respectively as on March 31, 2016.
